**TREASURER'S REPORT:** The Treasurer's Report has been circulated by email to all members. Jane summarised her report stating the club is in a healthy state and suggested members email her with any queries regarding the annual accounts.

- *Membership has recovered to 189, we had another good intake of new members from our bridge lessons. However, recovering membership numbers back to >200 continues to elude us.*
- *Table numbers and income remains consistent, and the committee sees no need to increase table money.*
- *Rental income increased over the year due to a few bespoke clients renting our rooms on an ad hoc basis. Rental income contributed 25% of our total income.*
- *In response to Shona's query, the Lottery Grant money was all used on the renovations.*
- *Committee agreed to increase annual membership subscription to \$110 to cover NZB levy.*
