MEMBERSHIP (as emailed to committee)

- Final membership expected to be ~170

FINANCIALS (as emailed to committee)

January's numbers are over inflated due to the Funding Grant received to fully renovate the toilet blocks. Work on the downstairs urinal commenced 22ndJanuary and is now complete. The financials will normalise as further renovation stages are paid for. January was also another good month for subscriptions with \$6,015 received. Rental income was down slightly due to the holiday period.

YTD Key Financial Results:

- Total Income \$124,080
- Total Expenses \$66,088
- Total Interest Income \$879
- Net Profit \$58,871
- Removing the grant money received and the renovation costs paid, produces a Net Profit result of \$14,333 (mostly from Subs and Nat Natarajan's very generous donation).
