FINANCIAL REPORT (Jane) as emailed to all committee

As expected, the painting cost (\$8700) and insurance renewal (\$8036) wiped out our net profit and ate into our cash reserves. Our \$10,000 term deposit matures on 10/5 to cover these costs. Our three sponsors have all renewed their support and have confirmed the same amounts as last year. Jane managed to get a \$600 reduction in insurance premium. Next year we will look at increasing excess (currently \$500) with a view to reducing premium.
