# **FINANCIALS** (as emailed to committee)

The first month in the new financial year produced the following key results:

- Income of \$7,482 (budget \$7,400)
- Expenses totalled \$9,902 higher than the \$8,175 budget mainly due to:
  - Wages (\$710 over) due to there being 5 weeks in the October pay period.
  - NZB Master Points (\$632 over) as the October invoice covered the period from July-Sept 24 which included A & B points for the tournaments run during that period.
  - Prizes & Presentations (\$374 over) for the sign writing of the honour's boards (\$350).
- Resulting in a Net Loss for the month of \$2,365, which should wash out over the next few months.
